Procurement legislation



The Swedish procurement legislation consists mainly of three laws.

- Act (2007:1091) on public procurement (LOU)
 - based on Directive 2004/18/EC
 - shall be applied by state and municipal authorities, decision-making bodies and controlled bodies for the award of a contract or the conclusion of agreements on goods, services and works.
- Act (2007:1092) on procurement in the water, energy, transport and postal services sectors (LUF)
 - based on Directive 2004/17/EC
- Act (2008:962) concerning the system of choice (LOV)

Complement, vihecles

- Act (2011:846) on environmental requirements in procurement of cars and some public transport services
 - This law aims to promote and stimulate the market for clean and energy efficient vehicles and to improve the transport sector's contribution to the European Union's common environmental, climate and energy policy.



Threshold



 The procurement may not be split up and the calculation may not be constructed in order to get under the threshold.
 Repeated purchases of the same category of goods and services during a financial year shall be added together.

- The government's special investigator Wijkman left the Procurement Commission's final report "A good business - a strategy for sustainable public procurement". The Committee's mission has been to provide a basis for making public procurement more efficient.
 - The report discusses how we in Swedish can use existing law and improved statistics to use public procurement in a strategic way and balance social, ethical and environmental considerations. When we subcontract activities the public procurement checomes entral to many areas of society. There are large economic values at stake, said civil and housing Minister Stefan Attefall.

Procurement Support Inquiry: Proposing new authority


A new authority include providing support in the form of information and guidance on procurement law, economics, environmental and social considerations. It proposes the investigation of a coordinated and efficient government procurement support.


